## How to interpret Attainment data (this is not your child's data)

Your child has been placed in one of five current attainment bands based upon their performance since September 2023. The bands indicate a likely GCSE grade at the end of their GCSE course.

## How to interpret your child's Religious Studies current attainment and examination grade (this is not your child's data)

The current grade and mock exam grade are two separate pieces of information. The mock exam grade is how your child performed in their exam in June against the elements of the course they have been taught. The current grade takes into account how your child has performed, in class and during assessments throughout the year. There may sometimes be a difference between the two grades.

Your child's grades have been colour coded to demonstrate performance against their Lowton target grade in Religious Studies.

GREENThe grade is above, equal to or one grade below the target grade.ORANGEThe grade is two grades below the target grade.REDThe grade is three or more grades below the target grade.
